#### 4. FIRST-AID MEASURES

<u>PROTECTION OF FIRST AID RESPONDERS</u>: Rescuers should not attempt to retrieve victims of exposure to this material without adequate personal protective equipment. Rescuers should be taken for medical attention, if necessary.

#### 6. ACCIDENTAL RELEASE MEASURES

<u>PERSONAL PRECAUTIONS AND EMERGENCY PROCEDURES</u>: An accidental release can result in a fire. Uncontrolled releases should be responded to by trained personnel using pre-planned procedures. Proper protective equipment should be used. Eliminate any possible sources of ignition, and provide maximum explosion-proof ventilation. Use only non-sparking tools and equipment during the response. #### 7. HANDLING and STORAGE

<u>PRECAUTIONS FOR SAFE HANDLING</u>: As with all chemicals, avoid getting this product ON YOU or IN YOU. Wash thoroughly after handling this product. Do not eat or drink while handling this material. Avoid contact with eyes, skin, and clothing. Avoid breathing fumes, dusts, vapors or mist. Do not taste or swallow. Use only with adequate ventilation. Keep away from heat and flame. In the event of a spill, follow practices indicated in Section 6: ACCIDENTAL RELEASE MEASURES.

CONDITIONS FOR SAFE STORAGE: This product is stable under ordinary conditions of handling, use and storage. Store containers in a cool, dry location, away from direct sunlight, sources of intense heat, or where freezing is possible. Do not allow containers to be exposed to elevated temperature (see Section 10. STABILITY and REACTIVITY); container rupture may result. Store away from incompatible materials (see Section 10: STABILITY AND REACTIVITY). Keep container tightly closed when not in use.
