## 7. HANDLING AND STORAGE

10. STABILITY AND REACTIVITY

**STABILITY:** Stable under normal storage and handling conditions.

**INCOMPATIBILITY:** Strong acids, bases, reducers and oxidizers.

HAZARDOUS DECOMPOSITION PRODUCTS: Oxides of carbon and nitrogen and other organic compounds.

HAZARDOUS POLYMERIZATION: Will not occur.

11. TOXICOLOGICAL INFORMATION

**INGESTION:** This is an unlikely route of exposure with an aerosol product. Ingestion may cause mucous membrane and gastrointestinal irritation and nervous system depression with symptoms of headache, dizziness, nausea, narcosis and unconsciousness. Aspiration into the lungs during ingestion or vomiting may cause serious lung damage which may be fatal.

**INHALATION:** Inhalation of vapors may cause mucous membrane and respiratory irritation and central nervous system depression with symptoms of headache, dizziness, nausea, vomiting, disorientation and stupor.
