ULTRAKOTE SAND FINISH is a proprietary mixture of Portland Cement, hydrated lime, silica and / or marble sand and proprietary additives. Sand Finish is available in #16 and #20 sand size.

## **Uses:**

Ultrakote Sand Finish is a premium ready-mixed finish texture material for use over Ultrakote 1 or Ultrakote pre-mix. Paint follows the Sand Finsh texture application.

# **Surface Preparation:**

Surface must be clean and free of bond-inhibiting materials such as dirt, dust, rust, grease, oil, efflorescence, mildew, fungus, form-release agents or any other contaminants. Remove and repair any loose paint, mortar, stucco, concrete or masonry by water blasting, sand blasting, scraping or using a wire brush. Repair all cracks with patching compound and prime the entire surface prior to application to avoid telegraphing lines through the dried finish.

# **Product Specifications:**

### Packaging:

90 lbs (40.9 kg) paper bag

### Coverage:

Approximate coverage are as follows:

35 ft<sup>2</sup> using #16 grit sand 40 ft<sup>2</sup> using #20 grit sand

Coverage will vary depending on temperature conditions and substrate.

### Color:

Natural Grey

### Clean up:

Clean tools and equipment with water immediately after use.

### **Shelf Life:**

1 year when stores in a cool dry location out of direct sunlight and kept from freezing.

# Mixing:

To begin, place 1 to 1.5 gallons of potable water into a mechanical mixer. As the mixer is running add one 90 lb bag of Sand Finish. Gradually add the remaining .5 to 1 gallons of potable water and blend until the desired consistency is achieved (about 4 to 5 minutes). Stop the mixing and allow the material to slake for 3 to 4 minutes. Then start the mixing again to break the initial set (usually 1 to 2 minutes). Working time per batch is 45 minutes or less. NOTE: The amount of water needed to reach the desired workability will vary with temperature, humidity, wind, exposure and site location or region.

# **Application:**

Sand Finish should be applied 2 to 3 days after the initial application of Ultrakote 1 or Ultrakote pre-mix, Ultrakote One Coat or the second coat of Ultrakote Traditional Stucco Cement. Sand Finish must not exceed a thickness of 3/8" in one application. Always work to a wet edge to avoid cold joints.

# Curing / Drying:

Sand Finish must be kept moist for at least 48 hours. Start light fogging after the initial set (1 to 2 hours). Finish should cure completely within 28 days.

# Limitations:

Sand Finish should be applied when surface and ambient temperatures are between  $38^{\circ}F$  (3.33°C) and  $110^{\circ}F$  (43.33°C) during application and cure time. Sand Finish is not recommended for use over painted surfaces or stucco accesories. Weather conditions will affect drying time and workability.

#### Precaution:

#### First Aid:
